Access to personal data: you have the right to know if a processing of personal data concerning you and - if confirmed - to obtain a copy;

Rectification: The interested party has the right to obtain from the data controller the correction of inaccurate personal data concerning him without unjustified delay;

Cancellation: The interested party has the right to obtain from the holder of the treatment the cancellation of personal data that they concern without unjustified delay and the data controller has the obligation to delete the data without unjustified delay personal;

Limitation of processing: the interested party has the right to obtain the limitation of the processing of his by the second art.18 of GDPR;

Portability of personal data: in the cases and in the ways provided for by GDPR, you can request that the data you have provided us with are rectified or cancelled, whether their processing is limited or whether they are transferred to another holder;

Opposition: You can object to the processing of your personal data in the cases and with the limits pursuant to art. 21 GDPR.

You cannot oppose treatments that the owner must comply pursuant to article 23 of GDPR
